TITLE: Subsidised Purchase of Competition Equipment (Boards & Skis)

PURPOSE

This policy pertains to Anglesea SLSC partially or fully funding members who are purchasing their first new surf craft - skis or boards.

POLICY

Anglesea SLSC is committed to supporting and assisting members to purchase equipment to be used for training and competition. It is the clubs policy to provide opportunities to its Under 21 members to access these craft in preference to Open” and “Masters” competitors. This policy is based on premise that the majority of “Open” and “Masters” competitors are working and should therefore be able afford their own craft. This applies to a member’s first purchase of a racing board or a single ski. It does not apply to the purchase of double ski’s.

Monetary support may be provided as:

- a) A reward for demonstrating outstanding results over a period of time; or
- b) For showing dedication within competition and other aspects of the club.

Please note: The Equipment Subsidy Program is subject to the constraints of the budget in any given year and this program can be put on hold without notice.

The following general, but not binding, principles, will guide a decision:

- *The applicant must have been an Anglesea member (and competed for the Anglesea Mentone Team) for the two immediately prior competition seasons.*
- *The applicant must have attended the majority of organised Senior training sessions in the most recent season completed.*
- *The Club considers that the applicant has satisfactorily carried out patrol duties in the season recently completed.*
- *If the demand for subsidy exceeds the budgeted amount then applicants will be ranked on the basis of training sessions and senior carnivals attended.*

Please also note the following additional terms:

- *Any member who has been the subject of disciplinary action cannot make application until 18 months after the date of that disciplinary action.*
- *Only 1 piece of equipment will be supported in a single calendar year.*

- *If the applicant is a Mentone member, they must first seek a subsidy through Mentone's program and any subsidy offered by Anglesea will be restricted to consideration of the amount not funded by Mentone LSC.*
- *If the applicant transfers his / her competition rights to another club (not including Mentone) in the 24 month period directly following the purchase date, the applicant agrees to repay the full amount of the subsidy. This must be done prior to transfer approval.*

Members must ensure they follow the procedure outlined below if they wish to receive support. If an order is placed and the process has not been followed in full, no support will be provided by the club in any circumstances.

Application Procedure

1. Complete the application form titled 'Application for Funding – Craft' (available from Club office). Applications should be received between July and October, with the final deadline being the 30th November each year. This is when budget considerations are made for the following season.
2. Submit your application to the Director of Surf Sport
3. The Director of Surf Sport will assess your application with a panel of assessors.
4. The panel will then, according to budgetary requirements, assign the following:
 - Not yet eligible
 - 25% contribution by the club/75% contribution by the member
 - 50% contribution by the club/50% contribution by the member
 - 75% contribution by the club/25% contribution by the member
 - 100% contribution by the club
5. Applicants will be notified as soon as practical, after a meeting can be called.
6. Once written approval from the Director of Surf Sports has been received, members may place an order with their chosen board or ski manufacturer by first obtaining a purchase order via the club's administrative assistant (Diane 5263 1107). If the member is to contribute to the purchase, this must be paid to the club prior to a purchase order being issued.
7. If members wish to purchase or find sponsorship for their equipment the existing club policy on competition equipment will apply. Refer to the Purchase of Competition Equipment Policy for more details.
8. The Club policy on equipment ownership will apply (refer Policy: 004).
